## **FAITH AND PUBLIC LIFE UPDATES**

### **Faith and inter faith response to Refugee crisis**

Faith and inter faith groups are often in the forefront of reaching out to respond to the needs of asylum seekers and refugees with both practical and spiritual support.

In recent months, it is the Syrian refugee crisis which has been the main focus of much faith community response although there has also been stepped up engagement by a number with the issues more widely. The City of Sanctuary movement has been playing an active role with faith groups in Leeds, Newcastle and a number of other 'cities of sanctuary' responding.

Inter faith prayer vigils have taken place in a number of areas. One took place outside Westminster Cathedral organised by CitizensUK and in Wisbech, people of different faiths came together "in solidarity with the Syrian refugees in their desperate and dangerous journey into Europe".

Faith groups in a number of areas have offered practical assistance. For example in Southend, church and other faith leaders wrote to the local paper saying that they and community groups would host people in their own homes and fund school places and offer help and advice to Syrian refugees who may be resettled in Southend <http://www.echo-news.co.uk/news/>. At Surrey University, Jewish, Muslim and Christian students worked together to raise funds towards providing tents in Calais and support for refugees on the Greek Island of Kos. Volunteers from Woking Mosque will deliver the Interfaith Aid. <http://www.jewishnews.co.uk/surrey-jsocs-pop-up-succah-inspires-interfaith-action-for-refugees/>

The topic was reflected at IFN's National Meeting, which took place on 14 October, both in presentations in plenary by Mustafa Field of Faiths Forum for London and MINAB and Nadine Daniel of Hope+ in Liverpool, and also in a special focus discussion group on 'welcoming the stranger' with contributions from the Revd Fleur Houston of the Churches Refugee Network and David Walsh of the Board of Deputies of British Jews. Interfaith Scotland's AGM on 4 November will be accompanied by a public talk on Scotland's Response to the Syrian Refugee Crisis.

## **Report on First Minister's interfaith summit in Scotland**

The First Minister of Scotland, the Rt Hon Nicola Sturgeon MSP, called an Interfaith Summit in September to find out more about the work being done by inter faith organisations and faith communities in Scotland. She met with a cross-section of religious leaders from diverse faith traditions along with the Director of Interfaith Scotland and project managers of Interfaith Glasgow and the Edinburgh Inter-faith Association. She said, "Inter faith work and the contribution of faith groups is essential in transforming lives and building a strong, fairer and equal Scotland. By working together with all communities I want to see a safer, stronger and more inclusive society which we are all able to fully contribute to and benefit from".

## **Counter Extremism Strategy**

On 19 October, Home Office Secretary Theresa May announced a counter-extremism strategy described as "aiming to tackle the full spectrum of harms caused by extremism: violent and non-violent, Islamist and neo-Nazi – hate and fear in all their forms". The release speaks of partnership at the heart of the strategy between government and individuals, groups and communities, who want to see extremism defeated - "a partnership that will not only seek to counter the ideology spread by extremists, but will stand up for the shared values that unite us as a country: values that include democracy, free speech, mutual respect, and opportunity for all."

The strategy sets out four areas in which action will be taken:

- confronting the extremist ideology head-on
- actively supporting those who want to fight extremism, but are too often disempowered or drowned out of the debate
- disrupting extremists, aggressively pursuing the key radicalisers who do so much damage

- building stronger and more cohesive communities, tackling the segregation and feelings of alienation that can help provide fertile ground for extremist messages to take root

## Community Engagement Forum

A Community Engagement Forum, foreshadowed in the Prime Minister's announcements of 20 July, met at Downing Street on 13 October to discuss countering extremism. In a holding Written Answer in the House of Commons, Home Office Security Minister John Hays said that "Attendance at forum meetings would rotate to allow ministers to hear directly from a wide range of individuals and groups taking a leading role in challenging extremism in our communities."

## Separate recording of anti-Muslim hate crimes

According to the Home Office report, *Hate Crime, England and Wales, 2014/15*, in 2014/15, there were 52,528 hate crimes recorded by the police, an increase of 18 per cent compared with the 44,471 hate crimes recorded in 2013/14, of which: 42,930 (82%) were race hate crimes; 5,597 (11%) were sexual orientation hate crimes; 3,254 (6%) were religion hate crimes; 2,508 (5%) were disability hate crimes; and 605 (1%) were transgender hate crimes. There was an overall increase of 18% on the previous year.

Prime Minister David Cameron announced at the first meeting of the Community Engagement Forum that for the first time, police forces in England and Wales will be asked to record anti-Muslim hate crimes as a specific category in the recorded crime statistics, bringing them in line with reporting of anti-Semitic attacks. Creating a separate category is intended to enable police, prosecutors, local authorities and the communities they serve to have a better understanding of the prevalence of anti-Muslim hate crime and allocate resources accordingly and to provide the first accurate picture of the extent of anti-Muslim hate crime in England and Wales.

## Review of Coroner Services

When the coroner reforms in the Coroners and Justice Act 2009 (“the 2009 Act”) came into effect in July 2013, the Government made a commitment to review their impact after they had been in place for 18 months. The aims of the 2009 Act were described by Government as being to put the needs of bereaved people at the heart of the coroner service; for coroner services to be locally delivered within a framework of national standards; and to enable a more efficient system of investigations and inquests.

This review seeks to find out whether the coroner reforms are operating as planned and whether there have been any unintended consequences. The Ministry of Justice is interested in hearing about people’s experiences of aspects of coroner services that were reformed under the 2009 Act.

This review will run from 15 October 2015 to 10 December 2015. The Government’s response will be published in early 2016.

## EHRC report on Review of equality and human rights law relating to religion or belief

Earlier this year the EHRC published the results of its consultation on how religion or belief affected experiences at work or when using services. It commissioned Oxford Brookes University to build on the findings of its consultation by reviewing the legal framework in Great Britain, the way courts have developed case law, and how experts have analysed this. The review looks at such key issues as how religion and belief are defined in the law, the legal protection for religion or belief, the balancing of competing rights, and the idea of a duty of reasonable accommodation, which is part of the law in Canada and America. The review takes a neutral approach and considers different views on these issues.

The review finds that the legislation and case law protects people with a religion or a belief and those who lack a religion or belief, but that several areas need more thought. These include the definition of belief and the position of the religious employer and religious service provider, and areas where the law is unclear such as the relationship between individual and group rights.

## **EHRC guide to increasing diversity in television broadcasting**

The EHRC has produced a guide intended to increase diversity in television broadcasting. Figures show that some groups may be experiencing barriers to getting into the sector and progressing when they get there. The television industry has long been aware of the need to increase diversity, both on- and off-screen so that the industry can attract the best talent, but also because of the unique role television broadcasting has in shaping and reflecting society's values. The guide is aimed at decision-makers within the industry, at independent production companies as well as broadcasters, talent suppliers and others – from production managers to legal and business affairs executives, directors and commissioning editors.

## **Inter Faith Network National Meeting and AGM**

IFN held its National Meeting and AGM on 14 October at the Bond Co in Birmingham.

The National Meeting was on the theme of 'Living Well Together'. 'Living well together' is an ongoing project: a journey, and learning from one another along the way is part of this. The meeting was a chance to explore many different dimensions of this and how inter faith cooperation can contribute to this yet further.

During the plenary session, Mustafa Field of the Faiths Forum for London spoke on 'Interconnecting in inter faith contexts for the common good'; Dr Karen Jochelson of the Equality and Human Rights Commission spoke on 'Equality and diversity'; Nadine Daniel of Hope+ and Merseyside Council of Faiths spoke on 'Reaching out at times of need'; Dr Maureen Sier of Interfaith Scotland spoke on 'Appreciating diversity; negotiating difference'; and Reflections on themes of the day were offered by Krishan Kant Attri of Newcastle Council of Faiths and Hindu Chaplain to the Armed Forces; Julie Jones of the Inter-faith Council for Wales and Church of Jesus Christ of Latter-day Saints, Wales; Dr Norman Richardson of the Northern Ireland Inter Faith Forum; and Jatinder Singh Birdi of Warwick District Faiths Forum.

Discussion groups were held on: 'Living well together: cooperating for community benefit', with a presentation by Mgr Daniel McHugh and colleagues (Khalid Mohammed and Mauricio Silva) from the Communitas wellbeing project at BIRINUS Birmingham; 'Living well together as neighbours', with a presentation from the Revd Mark Poulson of the Church of England and Near Neighbours; 'Living well together: faith communities and responding well to refugees and asylum seekers as part of our shared life', with presentations from the Revd Fleur Houston of the Churches Refugee Network and David Walsh of the Board of Deputies of British Jews; 'Living well together: snapshot from campus', with a presentation from Sukhi Kainth of the National Union of Students; 'Living well together within the workplace', with a presentation from Dr David Perfect of the Equality and Human Rights Commission and reflections from Dr Shuja Shafi of the Muslim Council of Britain; and 'Equipping us to live together well: religious literacy and chaplaincy', with presentations from Prudence Jones of the East of England Faiths Agency and the Revd Prebendary Michael Metcalf of the National Association of SACRES and Stafford and District Friends of Faith.

## Report on day event for local inter faith practitioners

As noted in the July/August issue of the e-bulletin, on 30 July IFN held a day event for local inter faith practitioners in London. This was the second of two such events held this year. The first was held in Sheffield in March.

- Active involvement of young people
- Responding together at times of tension
- Using Inter Faith Week to raise profile and widen engagement
- The value of different approaches - from grassroots dialogue and community projects to consultation and partnership with public agencies and other bodies
- The importance of initiatives that work with many faiths and also of those working with two faiths or three
- Resourcing the work
- The future of local inter faith - possibilities and challenges
- The vital importance of the work

National and regional faith, inter faith and academic and educational bodies in IFN's membership also make a vital contribution to the development of local inter faith understanding and cooperation. Some of the important ways that they do this have been covered in National Meetings and category meetings.

Local inter faith practitioners often comment on the significant impact that there can be from encouragement by national faith community organisations and other national and regional bodies to their local members to play an active role in local inter faith initiatives. It is hoped that the reports of the two day events may be useful in this work.

The meeting included discussion on some of the outcomes of the November 2014 Young Voices, Young Agents for Change meeting; and the question of 'religious literacy' and different programmes that are being developed to address this (at all ages) as part of increasing understanding about and between faiths.

## **Westhill NASACRE awards – an inter faith dimension**

The Westhill/NASACRE Awards have, for a number of years, been encouraging schools to engage with diversity through projects which will generate compelling learning experiences in RE for young people, relevant to today's context. Each year grants of up to £4,000 have been awarded to support suitable projects submitted by schools through their Standing Advisory Councils on Religious Education (SACREs). At IFN's Young Voices, Young Agents of Change event last Autumn, young people from one such project – Redbridge Ambassadors of Faith and Belief – spoke about their project which is about RE and also has a strong inter faith dimension. Among the 2015-16 grant recipients is a Faith Ambassador scheme in Barnet and Enfield where secondary School students are being trained as Faith Ambassadors, and delivering presentations in their local Primary Schools, and a digital project with secondary pupils, exploring Middlesbrough's religious heritage and connecting with faith communities today.

## **Nisa-Nashim Jewish-Muslim Women's Network launched**

A new initiative bringing together Jewish and Muslim women aimed at breaking down barriers and enabling joint work on projects helping wider society was launched at the Islamic Girls School in London this month. It is called Nisa-Nashim - made up of the word for women in Hebrew and Arabic. It also aims to promote women's leadership. The project received a start-up grant from the Department from Communities and Local Government.

Early activities have included visits to mosques and synagogues, hosted kosher-halal meals, the launch of a business network and support for programmes to help refugees.

## Sussex Police appoint 'Interfaith Champion'

Sussex Police have appointed an 'Interfaith Champion'. Sergeant Simon Kind holds this role alongside his full-time job as a response team sergeant. He describes his purpose as to assist Sussex Police meet its public sector equality duties of eliminating unlawful discrimination and fostering good relations between people with and without protected characteristics, including religion and belief. He chairs an internal Interfaith Forum where staff of any faith or belief can raise issues on how force policies may be affecting them. During Inter Faith Week they are hoping to host a series of blog posts on the force website where staff members describe how their faith or belief assists them in an often-difficult job.

The force also has four faith champions for Christianity, Islam, Judaism, Buddhism, Hinduism and Sikhism. They tend to be 'outward facing', dealing with groups in the community. Sergeant Kind is also responsible for engagement with other religions and beliefs, including Paganism and Humanism.

### Interfaith Scotland resources for school, youth and community groups
